

## Ithaca Yacht Club 2021 Slip Rental Agreement

May 1 through October 31, 2022

This is your Ithaca Yacht Club Slip Rental Agreement. You will receive a separate invoice for the summer's slip dues. Slip rates for 2022 have increased by approximately 3%. See: <https://ithacayachtclub.wildapricot.org/Marina>. There is a discount for early payment. Your invoice will be at the 2021 rate, but must be paid by February 1, 2022 to obtain the discount. Invoices will be adjusted to the full 2022 rate if unpaid as of that date.

Please complete the information requested below so that we may keep our records up to date. **Return a copy of this agreement, proof of at least \$300,000 in liability insurance (e.g., a certificate of insurance), and payment of the slip rental amount to: IYC, 410 East Upland Road, Ithaca, NY 14850.** Payment by check, rather than credit card, saves the club a considerable service charge.

Please note that if payment is not received by **March 1st**, your slip may be offered to someone on the waiting list. Current year membership dues must be paid before occupying your slip. No boat will be allowed in the marina until the rental and all associated fees are paid and proof of insurance provided.

It is specifically understood that any inspection of docks, moorings or storage areas by the Ithaca Yacht Club, Inc., its agents, or employees shall be for the protection of other members' boats and equipment and shall not be interpreted to mean that the Ithaca Yacht Club, Inc., its Officers, Board of Directors, Members, or employees accept any responsibility for the use or misuse of said docks, moorings or storage areas. Members are encouraged to make periodic inspections of their own docks, mooring equipment and storage areas and are expected to obtain their own hull insurance coverage.

I will follow the rules and regulations set forth by the Ithaca Yacht Club regarding use of Club facilities and the payment of all fees associated with my use of IYC Facilities.
